Welcome to the 2010-2011 School Year!

St. Veronica Parish is pleased to continue its tradition of offering quality Christ centered elementary education to its families. St. Veronica School exists as a part of the parish's mission to help parents educate their children in the Catholic way of life. We believe in the total development of the child – spiritually, academically, physically, and socially. St. Veronica School will continue to give its students a caring, loving environment where they will grow in both faith and knowledge. We acknowledge the contributions of our parishioners because it is their support and prayers that make our school possible.

St. Veronica School is home to over 480 students who enjoy outstanding academic programs in a Christian, disciplined atmosphere where all students have the opportunity to excel. The backbone of this experience is the dedicated professional staff, over half of whom hold Masters degrees.

The tuition rates for the 2010-2011 school year are: \$2,460.00 for half day kindergarten students and \$4,420.00 for full day kindergarten students; in-parish rates for grades 1-8 are \$2,980.00 for one student, \$5,787.00 for two students, \$7,998.00 for three students, and \$10,083.00 for four students. The out-of-parish tuition rate is \$4,505.00 for 1 student and \$8,760.00 for 2 students. There is an additional \$150.00 non-refundable registration fee for each family in grades K-8. There is a \$150.00 student fee per family for all students in grades K-8 (The registration fee and student fee will be waived for kindergarten students who have siblings registered in grades 1-8). All tuition can be financed through St. Veronica Parish via Automatic Bank Withdrawal.

We are definitely aware of the sacrifices most families make in order to send their children to Catholic schools. At the same time, we realize the rewards and benefits are immeasurable. This is an investment in your most valuable possession – your children. The parish will continue to help you by contributing the difference between your tuition and the actual cost to educate your child. Your continued support of the parish is necessary.

# **St. Veronica School Registration Procedures 2010-2011 School Year**

**Registrations will be accepted during the following time periods:**

**#1 February 15 through February 28, 2010**

- For all St. Veronica School students currently enrolled who are in grades K through 7. This period includes both “in-parish” and “out-of-parish” students currently enrolled and attending St. Veronica School.
- Registrations for siblings of currently enrolled “in-parish” students will be accepted at this time; siblings will be given priority in grades Pre-school-7. If the number of sibling registrations should cause enrollment to exceed capacity at any given grade level, admissions will be accepted by blind draw from registrations received in that registration period.

**#2 March 1 through March 15, 2010**

- For any parish member who wants to transfer a student from another elementary school to St. Veronica School in grades K-8. If the number of parish registrations should cause enrollment to exceed capacity at any given grade level, admissions will be accepted by blind draw from registrations received in that registration period. Registration for Pre-school will be accepted at this time for parish members

**#3 March 16 through March 31, 2010**

- For any “out-of-parish” family who wants to transfer a student from some other elementary school to St. Veronica School in grades K-8 and Pre-school.
- If the number of registrations should cause enrollment to exceed capacity at any given grade level, admissions will be accepted by blind draw among siblings of currently enrolled “out-of-parish” students first and then of new “out-of-parish” students.

**#4 After April 1, 2010**

- Registrations will be handled on a first come-first serve basis depending on capacity/student review.

It is imperative that families register during the assigned time periods in order to have the optimum chance of securing admission to St. Veronica School for the 2010-2011 school year.

Dear Parents,

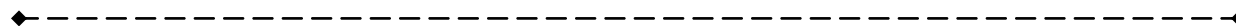
